No. B/120/A/73-MC (Vol. IV): It has been learned that the Nursing staff of RIMS Hospital, Imphal have resolved to strike without official intimation to the RIMS authority and also without giving opportunity to discuss their issues/grievances.

All the nursing staff of RIMS Hospital, Imphal are requested to kindly not to resort to any form of strike in the interest of Patient Care Services of the hospital and general public. The representatives of the RIMS Nurses Association Lamphelpat (RNAL) are requested to resolve any of their outstanding issues through mutually acceptable dialogue with the competent authority of the institute.

Despite being informed verbally through the Deputy Director (Admn.) and Administrative Officer, RIMS, Imphal to have a discussion with the Director, RIMS, Imphal today also the nursing staff representatives have refused to come to Administrative Block for further parleys. The Executive Committee of RNAL is still welcome to have dialogue with the Director, RIMS, Imphal in his office chamber to discuss their issues/grievances at the earliest.

Further, it is reiterated that as per Rule 7 (ii) of the Central Civil Services (Conduct) Rules, 1964 "no government servant shall resort to or in any way abet any form of strike in connection with any matter pertaining to his or her service or the service of any other government. servant".

If any of the employees of RIMS, Imphal resort to strike, disciplinary action will be taken against such employee for violation of Rule 7 (ii) of Central Civil Services (Conduct) Rules, 1964.
