- (i) Not exceeding 40 (Forty) years.
- (ii) Upper age limit shall be determined as on the last date of submission of the application form i.e. **18<sup>th</sup> July, 2024.**
- (iii) Date of Birth, as recorded in the Matriculation/Secondary Examination Certificate only, will be accepted for determining the age and no subsequent request for change will be considered or granted.
- (iv) The age concession to the PwD shall be admissible irrespective of the fact whether the post is reserved for PwD or not i.e. 10 years.
