CIRCULAR

Subject:

Prohibition of unauthorized Commercial Activities within the campus of RIMS, Imphal including in & around the residential quarters of RIMS, Imphal-

regarding

7749 It has come to the notice of the RIMS Administration that certain individuals, No. B/3602/2024-RIMS: including employees of RIMS, Imphal, are engaging in unauthorized commercial activities such as operating shops, stalls, and other commercial establishments inside the campus of RIMS, Imphal, including in and around the residential quarters of RIMS, Imphal, without prior approval from the Competent Authority of RIMS, Imphal. These activities have led to littering, causing environmental pollution, and disturbances to the campus residents.

- 2. It has also been observed that some individuals, including occupants of official quarters of RIMS. Imphal, are also selling plastic water bottles below 5 litres capacity, which are explicitly banned inside the RIMS campus as per this Institute's Order No. B/2689/2022-RIMS dated 30th September 2023.
- 3. As per the CCS (Conduct) Rules, 1964, particularly Rule 3(1)(iii) and Rule 3(1)(xv), the following are strictly prohibited: engaging in any activity that is unbecoming of a government servant, misusing one's position for personal gain, and engaging directly or indirectly in any trade or business, without approval.
- All individuals, including the staff of RIMS, Imphal, who are currently engaging in unauthorized commercial activities inside the campus of RIMS, Imphal, are instructed to cease all such activities immediately. Any stalls, shops, or other commercial setups found within the campus premises without proper authorization must be removed forthwith.
- All campus residents and employees are expected to comply with this order so as to maintain proper decorum and cleanliness inside the RIMS campus. Non-compliance with this order will attract necessary action, as deemed appropriate. Furthermore, stringent disciplinary action, as per the extant rules for violations of the CCS (Conduct) Rules, 1964, shall be initiated against the employees of RIMS, Imphal.
- Any instances of unauthorized commercial activities observed within the campus premises should be reported immediately to the Competent Authority of RIMS, Imphal.
- 7. This issues with the approval of Director, RIMS, Imphal.
