1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. - xi) The bidders should Obtained OEM certificate/Authorization only, not third-party authorization. The OEM should be responsible of warranty and CAMC. We M/s ....., declare that the above terms and conditions are accepted.

- xii) **The bidder should submit acceptance of 2 years warranty and 8 years CMC and submit CMC Charges “Additional documents 4”..**
- xiii) All necessary certificates for functioning of the machine should be obtained by bidders.
- xiv) **If any false information, documents provided to RIMS Imphal, all responsible should be bear by the bidder.**

23. **Turnover**

Bidder Turn Over Criteria: The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. 25. **Service & Support**

Availability of Service Centres: Bidder/OEM must have a Functional Service Centre in the State of each Consignee's Location in case of carry-in warranty. 28. **Warranty**

Bidder / OEM has to give an undertaking that after expiry of warranty period, it will provide Comprehensive Maintenance Service for next 5 years for the offered products at the rate not more than 5 % of contract price per annum. Buyer reserves the right to enter into a CMC agreement with the Successful Bidder / OEM after expiry of the Warranty period at above mentioned rate and the payment for the CMC charges would be made Annually after rendering of the CMC Services of the relevant CMC period. Performance Security of the successful bidder shall be forfeited if it fails to accept the CMC contract when called upon by the buyer. CMC would include cost of

#### 29. **Warranty**

The seller should guarantee the rectification of goods in case of any break down during the guarantee period. #### 30. **Warranty**
