No. B/3301/2024-RIMS: *18471* In pursuance of Circular No. Estt/01/2023-RIMS dated 01.06.2024 and subsequent Circular of even number dated 28.09.2024, the re-verification for recognition/renewal of the existing Associations of this Institute has been conducted by this Institute to ensure compliance with the provisions of the Central Civil Services (Recognition of Service Associations) Rules, 1993.

2. After a thorough examination of the documents submitted by the Associations, it has been observed that the following Associations of RIMS, Imphal, have submitted the requisite documents as stipulated in the aforementioned Circulars. Accordingly, these Associations are hereby recognized by the Institute as per the provisions of the CCS (Recognition of Service Association) Rules, 1993:-

5. For the other Associations, whose documents were found to be deficient, separate communications are being sent for rectification/updation before a final decision is taken in this regard
