

**No. B/RR/2024-RIMS:** In pursuance to the Ministry of Health & Family Welfare's Letter F. No.B/1011/82-RMC; In supersession of all previous notifications/orders in this regard, the Chairman, North Eastern Regional Medical College Society, Manipur is pleased to make the following rules regarding the methods of recruitment to the post as shown in Annexure, namely.

1. (Short title): This rule may be called the North Eastern Regional Medical College Society, Manipur Recruitment Rules, 1992 for the post of Technical Assistant (Electrical)
2. Application scale of pay, method of recruitment, etc. Classification of the said post, scale of pay, method of recruitment and other matters connected herewith shall be as specified in columns 3 to 13 of the said annexure-form.
3. Disqualification:
  - (a) No person who has more than one wife living or who having a spouse living, marriage in any case in which such marriage is void by reason of its taking place during the life time of such spouse shall be eligible for appointment to the aforesaid post and (b) no woman whose marriage is void by reason of husband living or a wife living at the time of such marriage who have married a person and who has a wife at the time of such marriage shall be eligible for appointment to the said post.
4. These rules shall come into force with effect from 6-10-92 provided that the Chairman, NERMC Society, Manipur is satisfied that there are special grounds for so ordering or exempt any person from the operation of these rules.
